## PRODUCT: OASIS 8500 CLEANSING SOLUTION

Description	:	OASIS 8500 CLEANISING SOLUTION
Material Type	:	Solvent based water emulsifiable degreasing solution.
Recommended Use	:	Suitable for removal of dirt,oil or grease from metal surfaces, machinery and other surfaces. Oasis 8500 solution may be used for degreasing painted surfaces. However, certain types of coating may be softened or affected by Oasis 8500 cleansing solution and it is recommended that a test be undertaken on a small area before proceeding with application to larger areas. Suitable for cleaning paint brushes and rollers. Oasis 8500 Cleansing Solution is not suitable for use a 'Quick Break' solvent degreasant for enclosed systems.
Recommended Application Method	:	Apply to the surface by brush or cloth and allow to stand for few minutes. Rinse off thoroughly with clean fresh water ensuring that any residual film of grease is entirely removed from the surface prior to painting. If the supply of fresh water is restricted wipe off with a water dampened cloth.

- Keep container tightly closed and keep out of reach of children. Do not use or store by hanging on a hook. Do not empty into wadis, drains or watercourses.
